I wish to draw your kind attention to this office letter no 20-Misc / 2009-Pers. IV dated 6<sup>th</sup> Nov'09, Pers Branch's letter no 1-9/2009-Pers. II dated 13<sup>th</sup> Oct'09 and subsequent reminder of even no. dated 17<sup>th</sup> Nov'09 wherein you were requested to relieve **non-optee/ DOT-optee/ Govt Status optee JTOs (Telecom)** to report to Director (Staff), DOT. Status of replies received are consolidated as per Annexure enclosed.

Some of the field units have reverted back giving details of vigilance cases pending against such officials. **It is hereby clarified that all such officials may be relieved immediately irrespective of the status of vigilance/ disciplinary cases pending against them, if any, for reporting to Dir(Staff), DOT.** BSNL optees (who opted within prescribed time limit) and whose absorption is pending due to Vigilance/ disciplinary cases are not to be relieved.

I would, therefore, request you to bestow your personal attention to instruct the concerned officer for immediate reliving of all non-optee/ DOT-optee/ Govt Status optees JTOs (Telecom) and furnish the compliance report by 20<sup>th</sup> Dec'09 positively to further apprise Dir(HR).
